been set in place. The height of the arch from the street to the center span is 22 feet.

The columns on each side are faced with Columbia River Basalt which was harvested in the Columbia River Gorge from a local quarry. This is the same stone used to construct the original Columbia River Scenic Highway built in the late

20's and early 30's. A time capsule located in the south column will be opened in 2110.

The original concept was the idea of the Troutdale Historical



Society which raised a third of the monies through fundraising.

Local corporations down to the grade school children contributed financially to this project. It is our hope that this will be a draw to our downtown and to the tourists who are attracted to the scenic spots along the old Columbia River Highway. ■

years later that they brought little Gracie home. Jerry said, "The hardest part was the waiting. It seemed like it would be a fairly short process and just took so long. There were so many disappointments along the way. Sometimes it felt like it would take forever." Apparently, China was making some big changes to their international adoption procedures including moving office locations and also making preparations for the winter Olympics in Beijing, which caused delays. Still, Jerry insists that China is one of the best countries to adopt from because they have a very systematic process and once you are logged into their system, after completing the required paperwork, it's not a matter of if you'll get a child, it's just a matter of when.

name was Li Qian. When the Stitzels saw the tiny picture of Gracie, who was decked out in quilted leopard print pants and a puffy hello kitty fabric jacket, they felt a special connection.

They had 24 hours from the time they received the email to "lock her in." They quickly found a pediatrician to review Gracie's special medical needs, which included crossed eyes, a droopy eyelid and a small head circumference and were given the encouraging

analysis that her conditions were correctable. They made the final decision to adopt Gracie on August 10, 2009.

Soon after, they discovered they would be traveling to China in October. After years of waiting, they had less than two months to prepare for their new daughter. Their adoption agency took care of all the travel arrangements and gave them all the information they'd need about expenses, travel schedule and expectations. Jerry says, "The adoption agency you choose is so important. Make sure you get with a good agency who knows what they're doing and can keep you on task and keep you motivated as time goes by, and frustrations rise, and patience wears thin." The Stitzels were very impressed with their agency, AWAA.
